The Shoreline Management Plan



Gosod dull strategol a rennir ar gyfer rheoli'r arfordir rhag perygl llifogydd ac erydu arfordirol


Sets out a shared strategic approach for managing the coastline from coastal flooding and erosion risks

Cynnal y llinell hyd at 2105

Dyhead i adeiladu neu gynnal amddiffynfeydd artifisial, fel bod lleoliad presennol y draethlin yn parhau. Gall hyn gynnwys cynnal neu newid safon yr amddiffyniad.

Hold the line (HTL) up to 2105

Aspiration to build or maintain artificial defences so the current position of the shoreline remains. Can involve maintaining or changing the standard of protection.





Cyngor Gwynedd	<ul style="list-style-type: none">- Pwerau i reoli perygl llifogydd o ddŵr wyneb, dŵr daear ac o nentydd llai- Awdurdod Llifogydd Lleol Arweiniol
Gwynedd Council	<ul style="list-style-type: none">- Powers to manage flood risk from surface water, groundwater and from smaller streams- Lead Local Flood Authority
Dŵr Cymru	<ul style="list-style-type: none">- Yn gyfrifol am reoli perygl llifogydd o allfeydd dŵr gwastraff
Welsh Water	<ul style="list-style-type: none">- Responsible for managing flood risk from waste-water outlets


