Hi Elinor,

Sorry about the delay in response.

The proposal does not appear to fall under Schedule 1 or 2 of the EIA regulations. The closest category would be Column 1 (b) as a water management project over 1.ha, but this category is specifically agriculture projects. You therefore aren't required to submit a screening opinion to us for a formal determination as to whether EIA is required.

You can still do so; however, we'd need more information from you to register it as a formal request. These are set out in the Regulations per below but include a location plan (i.e. red line plan) as well as more information about the environmental constraints and effects of the development. This could include, among other things, the impact on designated sites or protected species, heritage, and flood risk.

The Town and Country Planning (Environmental Impact Assessment) (Wales) Regulations 2017

Given the nature and ambition of the project, and it is not defined under Schedule 1 or 2, I'd say that its very unlikely we'd conclude that EIA was required. However, I can only offer an informal opinion. If you would like the Council to adopt one formally, we'd need more information, per the above link.

If a subsequent planning application was received it would still be screened on receipt, but this is normal procedure.
